

Virtual 341 Meeting of Creditors Information

Instead of going downtown to the United States Courthouse, until at least mid-October, all 341 Meetings of Creditors will be held virtually by phone or video conference. Here's what you need to know:

1. Make sure you are in a quiet place where you can speak freely.
2. Call in at least 5 minutes early.
3. Put your phone on MUTE. Do not unmute until your name is called.
4. Will will meet you on the conference.
5. You will be in a video/phone conference with other debtors and their attorneys. We have no control over whose case gets called first. Just listen for your name to be called.
6. You do not need to have anything with you. Will will have your bankruptcy petition and documents handy to help answer any questions.





Help with Zoom:

Zoom is very easy to use. 5 minutes before your meeting time, go to zoom.us/join and enter the Zoom ID and password shown above. Zoom may ask to download some software; if it does, click OK. You will be placed into a "waiting room" until the Trustee lets you in.


If you can't connect by video, you can just call in like a phone conference. To do that, dial (301) 715-8592 and enter the Zoom ID and password shown above. You will be placed in a "waiting room" until the Trustee lets you in.

How to Use Zoom On Any Smartphone or Computer

<p>1. Go to https://zoom.us/join</p>	
<p>2. Enter the Meeting ID for your Trustee</p> <p>3. Click Join</p>	
<p>4. Enter the Password for your Trustee</p> <p>5. Click Join Meeting</p>	
<p>6. You'll likely see this screen and then get a pop up that asks you to "Open Zoom Meetings." If you've already used Zoom before, it may just automatically start.</p>	<p>When system dialog prompts, click Open Zoom Meetings.</p> <hr/> <p>If you have Zoom Client installed, launch meeting. 7. Click Join with Computer Audio.

If you do not have a microphone on the computer you're using, call (301) 715-8592 to connect to the meeting by phone.



8. Use the controls at the bottom of the screen to mute your microphone, turn your video on, or leave the call.

Remember to stay on MUTE until your name is called by the Trustee.
